# **Our Highlights:**

**April 2014:** Project Coordinator inducted to run the BIG Lottery (Investing In Ideas) project to consult children and young people on what they see as the issues that most affect them and what solutions they would like to see.

**May 2014:** Recruitment campaign launched to build a team of volunteers to design and implement the consultation with the Project Coordinator.

**June 2014:** Recruitment process including interviews for new trustees to join the board.

**June 2014:** Training Day held with 14 prospective volunteers for the consultation project.

June 2014: Mission, Vision and Values reviewed and rewritten

**August 2014:** Consultation Subgroup review meeting held to review and support the team as they start meeting young people.

**September 2014:** Intern part funded by Santander joins the team along with a new volunteer office manager. Amongst other objectives they will review research papers.

**September 2014:** Student joins the team on placement from Dundee University to research and scope out the merits of volunteers supporting schools.

October 2014: New trustees join the board to enhance the experience and skills.

October 2014: Further Training Day held with volunteers for the consultation project with young people.

**November 2014:** New office computer system installed with cloud storage.

**November 2014:** Ragged University and People Know How continue to explore ways of working together support both organisations aims to mutual benefit.

**December 2014:** All subgroups established chaired by trustees.

**January 2015:** Christmas / New Year thank you party for the People Know How team on volunteers, students on placement, interns, staff and trustees.

January 2015: New twitter and facebook pages launched.

**January 2015:** Volunteer reviews finance systems and sets up new online system, making volunteer expenses easy to manage.

**February 2015:** Over 100 research papers reviewed to date with findings published on our website.

**February 2015:** Extensive work commenced to develop training resources with the support of Queen Margaret University, Open University and the Opening Educational Practices in Scotland project.

March 2015: Consultation workshops underway with young people across Edinburgh and East Lothian.

**March 2015:** Two new interns join the team from Spain and start work on establishing the Social Innovation Academy and running a consultation process with the Spanish speaking community in Edinburgh.

March 2015: Funding secured from One City Trust, Voluntary Action Fund (Scottish Government) and in kind support from businesses to run the Social Innovation Academy.

March 2015: Ongoing volunteers from Project Scotland support the development of People Know How.
